### ORDINANCE NO. 22-08

AN ORDINANCE AMENDING ORDINANCE NO. 14-23 OF THE LEE COUNTY BOARD OF COUNTY COMMISSIONERS AND CONSENTING TO AND AUTHORIZING THE MODIFICATION OF THE BOUNDARIES OF THE STONEYBROOK NORTH COMMUNITY DEVELOPMENT DISTRICT PURSUANT TO CHAPTER 190, FLORIDA STATUTES; DESCRIBING THE CONTRACTED BOUNDARIES OF THE DISTRICT: PROVIDING THAT THE TIME FOR GENERAL ELECTION OF SUPERVISORS SHALL BE CALCULATED FROM THE DATE OF THE INITIAL APPOINTMENT OF SUPERVISORS; PROVIDING THAT ALL OTHER PROVISIONS OF ORDINANCE NO. 14-23 SHALL REMAIN IN EFFECT; STATUTORY GOVERNING DISTRICT; **PERTAINING PROVISIONS** THE MODIFICATIONS THAT MAY ARISE FROM CONSIDERATION AT PUBLIC HEARING: PROVIDING FOR CONFLICT, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Stoneybrook North Community Development District (the "District") was created by Lee County Ordinance No. 14-23, approved by the Lee County Board of County Commissioners (the "County") on December 16, 2014 (effective date December 18, 2014), and encompasses 399.64 acres, more or less; and

WHEREAS, the District has petitioned the County to adopt an ordinance contracting the boundaries of the District pursuant to Chapter 190, Florida Statutes, by removing approximately 16.48 acres from the boundaries of the District (the "Petition"); and

WHEREAS, the real property constituting the approximately 16.48 acres to be removed from the District is described in the attached Exhibit "A"; and

WHEREAS, the owners of the approximately 16.48 acres to be removed from the District, as described in Exhibit "A," have consented in writing to the removal of such property from the boundaries of the District; and

WHEREAS, the Petition seeks, by way of removing the real property described per parcel in Exhibit "A," to designate all of the real property described in Exhibit "B" as land within the District, for which the District is authorized to manage and finance basic service delivery; and

WHEREAS, staff review of the request to modify the boundaries of the Stoneybrook North Community Development District and all related information indicates there is no rational basis to refuse the request set forth in the District's petition; and

WHEREAS, the County has held a public hearing on the Petition in accordance with the requirements and procedures of Sections 190.046(1)(f), Florida Statutes; and

WHEREAS, the County has considered the record of the public hearing and the factors set forth in Section 190.005(1)(e), Florida Statutes.

# NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA:

### SECTION ONE: FINDINGS OF FACT

The County hereby finds and states that:

- 1. the "WHEREAS" clauses stated above are adopted as findings of fact in support of this Ordinance;
- 2. the contraction of the District is not inconsistent with any applicable element or portion of the State Comprehensive Plan or the County's Comprehensive Plan;
- the area of land within the contracted District is of sufficient size, is sufficiently compact and is sufficiently contiguous to be developable as one functional interrelated community;
- 4. the community development services and facilities to be provided by the contracted District will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and
- 5. the area that will be served by the contracted District is amenable to separate, special district government; and
- 6. the granting of the Petition complies with the requirements of Chapter 190, Florida Statutes; and
- 7. upon adoption of this Ordinance, all provisions of County Ordinance No. 14-23, will continue to be effective, except as modified herein.

### SECTION TWO: CONCLUSIONS OF LAW

- 1. This proceeding is governed by Chapter 190, Florida Statutes;
- 2. The County has jurisdiction pursuant to Sections 190.005(2) and 190.046(1)(f), Florida Statutes; and
- 3. The granting of the Petition complies with the dictates of Chapter 190, Florida Statutes.

### SECTION THREE: BOUNDARY CONTRACTION AND ELECTION OF SUPERVISOR

The area of land described in the attached Exhibit "A" is hereby removed from the geographical boundaries of the District. Accordingly, all of the real property identified in Exhibit "B," encompassing 383.16 acres, more or less, is now designated as land within the District. Contraction of the boundaries shall not affect the time for transition to the general election of supervisors by qualified electors of the District, in accordance with Section 190.006(3)(a)2., Florida Statutes, which time shall be calculated from the date of the initial appointment of the supervisors.

### SECTION FOUR: STATUTORY PROVISIONS GOVERNING THE DISTRICT

The Stoneybrook North Community Development District will continue to be governed by the provisions of Florida Statutes, Chapter 190.

### SECTION FIVE: MODIFICATION

It is the intent of the Board of County Commissioners that the provisions of this Ordinance may be modified as a result of consideration that may arise during Public Hearing(s). Such modifications shall be incorporated into the final version.

### SECTION SIX: CONFLICT AND SEVERABILITY

In the event this Ordinance conflicts with any other Lee County ordinance or other applicable law, the more restrictive will apply. If any phase or portion of this Ordinance is held invalid or unconstitutional by any court of competent jurisdiction, such portion will be deemed a separate, distinct and independent provision and such holding will not affect the validity of the remaining portion.

### **SECTION SEVEN: EFFECTIVE DATE**

This Ordinance becomes effective upon filing with the Office of the Secretary of the Florida Department of State.

The Stoneybrook North Community Development District is a uniform community development district established by the Board through adoption of LCO #14-23 on December 16, 2014.

Currently, the Stoneybrook North Community Development District is comprised of 399.64 acres and has the power to finance, fund, plan, establish, acquire, construct or reconstruct, enlarge or extend, equip, operate and maintain systems and facilities for the following basic infrastructure: water management; water supply; sewer and waste water management; bridges and culverts; district roads; and other projects within or without the district boundary for which a development order is issued.

In accordance with Florida Statutes Ch. 190, the Stoneybrook North Community Development District has petitioned the Board of County Commissioners to conduct a public hearing for the purpose of adopting a non-emergency ordinance to contract the Stoneybrook North Community Development District to remove 16.48 acres contiguous to the original Stoneybrook North Community Development District property and amend the district's external boundary.

The Stoneybrook North Community Development District's request for boundary contraction is consistent with the Lee County Comprehensive Plan. All development activity within the boundaries of the District will be subject to the Lee Plan and all related land development regulations.

Staff has reviewed the factors set forth in F.S. §190.005(1)(e) and finds no new information relevant to those factors that is inconsistent with the contraction of District boundaries.

The Office of the County Attorney and Planning Staff recommend that the Board of County Commissioners grant the Stoneybrook North Community Development District's petition by adopting the proposed amendment to LCO #14-23.
